



OTTAWA EAGLES SOCCER ACADEMY PLAYER AGREEMENT CONTRACT

1. TERM OF AGREEMENT

This contract is valid for the 2025 spring/summer season, beginning on May 1st, 2025, and ending on September 30th, 2025.

2. PLAYER COMMITMENTS

By signing this agreement, the Player agrees to:

- Attend all training sessions, games, and team meetings, unless excused by the coach.
- Show commitment, discipline, and respect towards coaches, teammates, opponents, and referees.
- Follow the Academy's code of conduct and policies.
- Purchase the official Ottawa Eagles Soccer Academy jerseys and uniform as required by the team.

3. ACADEMY COMMITMENTS

The Academy agrees to:

- Provide structured training sessions led by qualified coaches.
- Offer a safe and supportive environment for player development.
- Arrange matches and other soccer-related events as part of the season.

4. PAYMENT TERMS

- **The Parent/Guardian agrees to pay the seasonal fee of \$825 to the Academy.**
- Payment must be made in full by May 20, 2025, or in installments as agreed with the Academy.
- Fees are non-refundable, except in cases of serious injury (with medical proof) or special circumstances reviewed by the Academy.
- Players are also responsible for purchasing their own jerseys and uniforms as required by the Academy.

5. TERMINATION

The Academy reserves the right to terminate this contract if the Player fails to comply with

team rules, payments, or demonstrates detrimental to the team. No refunds will be issued upon termination due to disciplinary reasons.

6. LIABILITY WAIVER

The Player and Parent/Guardian acknowledges that participation in soccer involves risks.

The Academy, its coaches and staff shall not be held responsible for any injuries or damage or losses incurred during training, games, or Academy-related activities.

7. PHOTO & MEDIA CONSENT

By signing this contract, the Player (or Parent/Guardian, if applicable) grants permission to Ottawa Eagles Soccer Academy to take photographs and videos of the Player during training, games, and Academy events. These images and videos may be used for promotional purposes, including but not limited to social media, the Academy's website, and marketing materials. If the Player (or Parent/Guardian) does not consent to this, they must notify the Academy in writing.
